*Please address these questions:* Do you have any relatives in Australia or in Perth? What is your plan in regards to your accommodation in Perth? How far do you need to travel from your proposed accommodation to APSI campus?

**QUESTION 4: Tell us about why you chose to study with APSI.**

*Please address these questions: Why did you choose APSI compared to other colleges in Australia? How did you find out about APSI? How can you assure APSI that you will not transfer to other provider after your visa is obtained?*

*Please address these questions: How will this training course benefit your future? How is this training course related to your previous studies? If this training course is not related to your previous studies, why have you decided to change your career path? What do you know about this training course? Will it be easier or harder to get a job with an Australian qualification? How much do you expect your monthly salary to be after completing your qualification in Australia? How does this compare to the salary you would receive if you did a degree in your own country?*
